"Health Guarantee"

Congratulations on the purchase of your new puppy from **Little Mountain Puppies**. We have made every effort to provide you with a healthy and happy puppy. Your puppy has been vaccinated and dewormed. The said animal is free from disease and physical defects as appears to the eye unless otherwise stated below.

"**Little Mountain Puppies**" will guarantee the said animal against life threatening congenital or hereditary defects (i.e. heart murmur over point 3, liver shunt, and crippling hip dysplasia) for up to 1 year from date of birth.

The purchaser agrees to have the dog examined by a veterinarian as soon after purchase as feasible. **If the animal is not seen by a licensed veterinarian within 5 days from date of Transfer and a copy of the veterinarian certificate be emailed to us withing 5 Days, all guarantees are voided,** and said animal is not seller's responsibility, and no monies shall be refunded.

If within the said time period upon examination, a licensed veterinarian finds the animal to have a serious defect, then the purchaser must contact **Little Mountain Puppies** within 24 business hours and produce the animal to the seller's designated veterinarian within 4 business days of the vet visit. Purchaser's failure to produce the animal within 4 business days for examination will nullify seller's obligation to replace, refund, or reimburse, except otherwise provided by law. If, in the unlikely event the puppy dies within this 1 Year time period. Buyer must provide veterinarian's certification to the seller within 5 days of receiving it. If the cause is not known an autopsy will be required.

If said animal would be found to have any parasites or anything not live threatening (example: fleas, worms, skin irritation, kennel cough, coccidian, giardia, or ear mites, etc.) it is the buyers responsibility to treat these or any similar at buyer's expense. Seller will NOT be responsible for factors beyond their control, including, but not limited to: negligence, cruelty, accidental injury, exposure to disease carrying animals, stress resulting from change in diet or environment, hypoglycemia, kennel cough, retained baby teeth, off bites, umbilical hernia, undescended testicles, inguinal hernia, or any other expense except as otherwise provide by law.

Breeder will not be responsible for Parvo, Distemper or Corona Virus after 48 hours of the sale; these diseases are highly contagious and can be contacted immediately after leaving the breeder. We will not be responsible for any illnesses that are diagnosed after this time period. Veterinarian checkups and vaccinations must be kept current for any warranties or guarantees to be valid. This contract is for the original buyer that purchased a dog from **Little Mountain Puppies**. If terms and conditions are not fulfilled, then this contract is null and void. Buyer agrees to ensure your puppy's health by providing good food, housing and good medical care to keep health guarantee in effect. Responsible owner/buyers will provide puppy with routine preventive care and all immunizations and exams by licensed veterinarian. By signing below buyer acknowledges receipt of a copy of this agreement. Seller will not be responsible for any veterinary expenses, or any other expenses incurred by the buyer.
